How does the program work?

Obtain a list of your electric accounts, including utility rates and zip codes of service addresses, found on your PECO bill.

- Authorize PECO to release this information by filling out the letter of authorization provided by Exelon Energy. Please make sure to use the legal entity name.
- Review Exelon Energy's contract and secure credit approval before asking for final pricing.
- Set a date for final pricing.
- Return signed contract and Tax Exempt form (if applicable).
- Your switching date/enrollment date, will depend on your meter read cycle. To switch before your next bill, the process must be completed 19 days before your next meter read (see below for meter read date). An Exelon Energy representative will help you with the transition timing.

Will my electric service reliability be affected?

Your electric service reliability will remain the same should you choose a Competitive Retail Energy Supplier. PECO will continue to distribute the electricity you purchase. They will continue to service and maintain the poles and wires (infrastructure) and will assist you with day-to-day reliability and service issues.

You will receive 2 bills, one from PECO and one from Exelon Energy (See below for an example of the breakout).

- Exelon Energy will begin to provide "generation" and "transmission" service.
- PECO will continue to provide "distribution" service.
- The "transition" charges are eliminated (as of January 1, 2011).
